The zero draft offers a strong argumentation for the necessity of a dedicated culture goal, and we see five key reasons: Firstly, to ensure adequate focus on culture at the highest governmental level. Secondly, to ensure the comprehensive consideration of the range of connections between culture and other policy areas. Thirdly, to foster a sense of engagement and ownership of the goals within the culture sector itself. Fourthly, to activate all other goals and strengthen their achievement through the mobilizing power of culture. And fifth, to safeguard the attainment of all goals from systemic and behavioral barriers that can indeed be addressed through a cultural lens.

I will concentrate on the question 'advocacy for what,' aiming to distinguish three distinct sets of issues. These encompass varying timelines, diverse challenges, and potentially differing technical requisites. First, advocacy for the significance of culture within the sustainable development agenda. Second, advocacy for the necessity for a dedicated cultural goal within the post-2030 development framework. Lastly, advocacy for the principle that postponement until 2030 is untenable. The key in moving forward in 2024 will be to articulate in the right way those three dimensions of advocacy.

We did a keyword count and 'culture' accounted for 5% of the keyword set 'society-economy-environment-culture' in the national reports, whereas the other keywords ranged between 25-30%. However, in the local reports, the picture was brighter, with 'culture' comprising 13% of the same set of keywords.
